- 8 Interpret ethical and legal considerations surrounding end-of-life care, advance directives, and patient autonomy, balancing personal, cultural, and professional values.
- 9 Integrate theoretical bioethical principles into practical case studies, developing informed and ethically sound positions on contemporary healthcare challenges.
