Keynote: Jen Gunter, MD

Two-Time New York Times Best-Selling Author & TED Podcast Host

Dr. Jen Gunter is an OB/GYN and pain medicine physician, and the author of two New York Times best-selling books, The Menopause Manifesto, and The Vagina Bible (translated into 15 languages and counting). She has written for the NY Times, the Globe and Mail, Glamour, Cosmopolitan and numerous other outlets. You can find her opinions regularly posted on Substack (TheVajenda.com), Twitter (@drjengunter) and Instagram (DrJenGunter). Jen is the host of TED's highly-rated podcast, Body Stuff with Dr. Jen Gunter, and her TED Talk, "Why can't we talk about periods?" was the third most popular TED Talk of 2020. Jen is also the host of Jensplaining, the top-rated series on CBC Gem.

Jen has been called Twitter's resident OB/GYN and the world's most famous gynecologist. She is a fierce advocate for facts and tirelessly calls out those who exploit pseudoscience for financial and political profit. Dr. Gunter is on a mission to help people separate medical fact from fiction with her writing and activism.

Trained at Yale and the University of Chicago, Dr. Lisa Larkin is a board-certified internist and midlife women's health expert who has practiced in both academics and private practice since 1991 in Cincinnati, Ohio. Dr. Larkin is passionate about raising the standard of care for women and advancing evidence-based women's healthcare. She is currently Founder and CEO of Ms.Medicine, a national health care organization dedicated to advancing women's health on a broader scale through innovation in care delivery models and consumer and clinician education. She is also Founder and President of Lisa Larkin, MD and Associates, an independent, multispecialty practice, where she continues to practice, offering comprehensive primary care and women's specialty health care through a direct care membership model. Considered a national expert in menopause management, sexual medicine and breast cancer risk assessment and prevention, and migraine, Dr. Larkin is a well-known clinician educator, and lectures frequently at physician CME programs and educational events on women's health topics. Dr. Larkin formerly served as Associate Professor and Division Director of Midlife Women's Health and Primary Care at the University of Cincinnati College of Medicine and as the Director of the UC Health Women's Center (2012-2016). She is a Fellow of the American College of Physicians, a certified menopause clinician (NCMP), a Fellow of and past member of the Board of Directors of ISSWSH (International Society or the Study of Women's Sexual Health), and currently serves on the Board of Trustees of NAMS (North American Menopause Society).

Rachel Rubin, MD, IF, NCMP

Assistant Clinical Professor in Urology, Georgetown University Hospital

Dr. Rachel Rubin is a board-certified urologist and sexual medicine specialist. She is an assistant clinical professor of Urology at Georgetown University and works in a private practice in the Washington DC region. She is one of only a handful of physicians fellowship trained in male and female sexual medicine. Dr. Rubin is a clinician, researcher, and vocal educator in the field of sexual medicine. She completed her medical and undergraduate training at Tufts University, her urology training at Georgetown University, and her fellowship training under Dr. Irwin Goldstein in San Diego. In addition to being education chair for the International Society for the Study of Women's Sexual Health (ISSWSH), she also serves as an Associate Editor for the Journal Sexual Medicine Reviews.

Director, Female Sexual Medicine, Center for Pelvic Medicine/Professor, OB/GYN, Drexel University College of Medicine

Susan Kellogg-Spadt PhD, CRNP, IF, CSC, FCST is the Director of Female Sexual Medicine at The Center for Pelvic Medicine in Bryn Mawr, Pennsylvania. Dr. Kellogg performs direct patient care, consultative services as a vulvovaginal and pelvic pain specialist, researcher, educator, sexual dysfunction clinician and therapist. Dr. Kellogg is Professor of OB/GYN at Drexel University College of Medicine; Professor of Human Sexuality at Widener University and Clinical Associate faculty at the University of Pennsylvania and Thomas Jefferson University in Philadelphia. Dr. Kellogg is a certified sexuality counselor and therapist. She has authored and coauthored several books, chapters and peer reviewed articles in the field of sexual medicine. She has been featured in The New York Times and on the Today Show, 20/20, CNN, and the Discovery Channel.



Sharon Parish, MD

Professor of Medicine in Clinical Psychiatry/Professor of Clinical Medicine, Weill Cornell Medical College

Dr. Sharon J. Parish is a Professor of Medicine in Clinical Psychiatry and Professor of Clinical Medicine at the Weill Cornell Medical College and the Director of Medical Services at the New York Presbyterian Hospital/Westchester Division. She received her medical degree from Albany Medical College of Union University, completed her residency in Internal Medicine at George Washington University Hospital, and behavioral medicine fellowship at New York University/Bellevue Hospital Center. Dr. Parish is an internal medicine physician who is a fellow of the International Society for the Study of Women's Sexual Health (ISSWSH) and a North American Menopause Society Certified Menopause Practitioner. For 22 years (1992-2014), she was a clinician educator on the faculty of the Albert Einstein College of Medicine and the clinical staff of Montefiore Hospital, Bronx NY, where she had a large primary practice and an array of teaching and administrative responsibilities. Currently (2014-present), her internal medicine practice focuses on behavioral health, menopause, and sexual medicine for female and male patients at Weill Cornell Medicine in New York City.

Dr. Parish has a special interest in practice, training, and research in behavioral health, sexual medicine, and menopause. She has designed many educational programs on sexual health; menopause; alcohol and substance use disorders; psychiatric care for the medical patient; sexual medicine and other specialized communication skills; and curriculum development for undergraduate, graduate, and postgraduate medical education across multiple disciplines. She has authored many publications and online materials on an array of related topics. Her academic activities have also included participation in international and national society committees and consultantships; lectures, symposia, and web-based educational programs; and national and international society leadership roles.

She is Past President of the ISSWSH (2014-2018), Chair of the ISSWSH Clinical Practice Guidelines Committee (2016-2023), member of the ISSWSH Board of Directors, and past Chair of the ISSWSH Education Committee (2002-2014). She is a member of the International Society for Sexual Medicine (ISSM) Board of Directors (2018-2022) and Consultation and Guidelines Committee. Dr. Parish is an Associate Editor for Sexual Medicine Reviews (2017-present) and previously Associate Editor for CME (2006-2014) and Assistant Editor for Female Medical/Surgical for the Journal of Sexual Medicine (2014-2016).
